Defense counsel shall notify plaintiff's counsel within thirty (30) days of the date of this Order if their client was incorrectly named in the Complaint. Counsel may be barred from raising this defense at a later time for failure to comply.

Any jurisdictional motions must be filed in accordance with the Court Rules or be waived.

Any *forum non conveniens* motions must be filed as soon as practicable; once sufficient discovery is conducted so that the motion may be properly brought.

Trial Counsel designations are hereby waived due to the age of these cases or extremis health condition of the plaintiff(s).

To the extent possible, documents requested in a deposition notice directed to an expert shall be produced three days in advance of the expert deposition. The expert shall not be required to produce documents that are readily accessible in the public domain. Plaintiff and defendants may consent to an extension for

completion of these depositions.

December 14, 2023 Any motion to deconsolidate must be filed by this date. No motion to deconsolidate may

be filed until product identification testimony is completed as to the respective plaintiff. Plaintiff's counsel and defendant's counsel may consent to a deconsolidation of an
