POWER PLAYERS: TOP PLAINTIFFS' FIRM DONORS

Since 2017, the 20 top plaintiffs' firms in Nevada contributed a combined \$4.56 million to political candidates and committees in the state. Of these firms, Richard Harris Law and Claggett & Sykes were the two largest donors, contributing approximately \$860,000 and \$650,000 respectively. Four other firms – Panish Shea & Boyle, Bradley Drendel & Jeanney, Kemp Jones and Benson Bertoldo Baker & Carter – gave more than \$300,000 since 2017, with two additional firms giving more than \$225,000.

TOP RECIPIENTS FROM TOP PLAINTIFFS' FIRMS

The overwhelming majority of campaign contributions from Nevada's Top 20 statewide plaintiffs' law firm campaign contributors went to one committee since 2017: Citizens for Justice. This political action committee, run by the Nevada Justice Association, received a total of more than \$4.727 million in contributions since 2017, more than \$2.8 million of which was from the Top 20 firms listed previously. Save for Consumers for Judicial Equality, the rest of the Top 20 recipients are individual candidates, with all these candidate committees receiving money from multiple law firms.

Former Nevada Governor, Democrat Steve Sisolak, received more than \$130,000 in political contributions from trial lawyers and their firms. Adam Ganz, a Las Vegas trial lawyer, received \$133,000 from fellow trial lawyers toward his two failed campaigns for a judgeship in Department 17 of Nevada's 8th Judicial District Court. After his electoral defeats, Ganz applied for and was named the 8th Judicial District Court's Alternative Dispute Resolution/Discovery Commissioner in July 2023. Nevada Attorney General and trial lawyer Aaron Darnell Ford also received sizable campaign contributions from members of the state's trial bar, receiving more than \$80,000 from his peers.

CITIZENS FOR JUSTICE PAC RECIPIENT ANALYSIS

Citizens for Justice, the political arm of the Nevada Justice Association, has “long dominated” trial lawyer political contributions.[1] An analysis by the Nevada Independent found that the political action committee was the third-largest single contributor in Nevada from the 2022 cycle, falling only behind the Nevada Association of Realtors and MGM Resorts International.[2] One reason for this is due to Nevada’s campaign finance regulations. Citizens for Justice, as an independent political action committee, is not subject to campaign finance regulations like individual campaigns are to the tune of a \$5,000 contribution limit.[3] An analysis of the money given by Citizens for Justice has seen most of the money pushed into its own affiliated groups, although the organization also pushed campaign contributions to various candidates, often to Democrats.[4]

POWER PLAYER SPOTLIGHT

Richard Harris Law and Claggett & Sykes are the two largest trial law firm campaign contributors in the state of Nevada, contributing about \$860,000 and \$650,000 respectively. Much of the money contributed by the law firms went to the Citizens for Justice PAC, with the two firms contributing just under \$1.1 million to the committee since 2017. Approximately \$40,000 from the two firms went to failed 8th Judicial District candidate (and trial lawyer) Adam Ganz.

Richard Harris Law

Top recipients of campaign contributions from Richard Harris Law include \$700,000 donated to the Citizens for Justice PAC.

Claggett & Sykes

The Citizens for Justice PAC also was the top recipient of political giving from the Claggett & Sykes law firm, accounting for more than 60% of the firm's total giving since 2017. Claggett & Sykes was the only Top 20 plaintiffs' firm to contribute to Consumers for Judicial Equality, a campaign committee that backed former Nevada Supreme Court Justice Ozzie Fumo's unsuccessful 2020 reelection bid.

Panish Shea & Boyle gave more than 70% of all of their political giving dollars to the Citizens for Justice PAC since 2017.

Campaign Contributions from Top Nevada Legal Services Advertisers

Eleven of Nevada's top local legal services advertisers have donated money directly to candidates and committees in Nevada, totaling approximately \$1.6 million. The biggest donor is Richard Harris Law, donating more than \$850,000 to candidates and committees since 2017. Three additional firms – De Castroverde Law, Edward Bernstein & Associates and Henness & Haight –each donated more than \$175,000 to political campaigns and committees.

Twenty-one candidates and committees received \$10,000 or more from the top local legal services advertisers in Nevada, with a vast majority of the money – nearly \$1 million – going to the Nevada Citizens for Justice, the political arm of the Nevada Justice Association.

INTERESTING DATA POINTS AND ANALYSIS

Nevada's 8th Judicial District

Of the candidates receiving more than \$30,000 in campaign contributions from the Top 20 plaintiffs' firm donors in Nevada, 10 were candidates running for judge in various departments of Nevada's 8th Judicial District, which encompasses Clark County and Las Vegas. None of these firms played in any other Judicial District race at the level of the 8th Judicial District.

These candidates include:

- Adam Ganz, who received \$133,000 and unsuccessfully sought a seat on the 8th Judicial District Court on two occasions;
- Maria Gall, who received \$66,000 in her successful race for a seat on the 8th Judicial District Court;
- Jacqueline Marie Bluth, who received \$48,500 in her successful race for a seat on the 8th Judicial District Court; and,
- Rob Bare, who received more than \$48,000 in his unsuccessful race for a seat on the 8th Judicial District Court.

A Focus On Judicial/Law Giving

Out of the Top 20 candidate recipients from the Top 20 plaintiffs' firm campaign donors in Nevada, only two of those candidates were not running for a judicial-affiliated role (Steve Sisolak for Governor and Ozzie Fumo for Nevada State Assembly, District 21). Of those candidates, 10 were candidates running for judge in various departments of the 8th Judicial District Court, two were running for Justice on the Nevada Supreme Court, two were running for a seat on the Nevada Court of Appeals, one (Aaron Darnell Ford) was running for Attorney General, and one (Steven B. Wolfson) for Clark County District Attorney.

A Note on Methodology

Due to an inability to search by employer or job title, this data was populated by generating a list of top trial bar contributors to Citizens for Justice, the PAC affiliate of the Nevada Justice Association, which is the trial lawyer trade group. With these limitations, the data used in this report was from direct law firm contributions to each candidate and committee. Individual campaign contributions by lawyers for the various firms were not used.
