

COMBINED GIVING TO TOP TRIAL LAWYER PACS

Since 2017, the two top political action committees for Pennsylvania's trial bar – LawPAC and the Committee for a Better Tomorrow – received a combined total of more than \$15.375 million in donations from plaintiffs' firms. LawPAC is the political action committee of the Pennsylvania Association for Justice, previously called the Pennsylvania Trial Lawyers Association. The Committee for a Better Tomorrow is the political action committee of the Philadelphia Trial Lawyers Association.

Four plaintiffs' firms gave more than \$1 million, with two additional firms donating more than \$600,000 to the two PACs. Another ten firms gave more than \$125,000.

TOP RECIPIENTS OF TRIAL BAR PAC MONEY

Since 2017, 22 candidates for Pennsylvania elected office and political committees received more than \$175,000 in combined campaign contributions from LawPAC and the Committee for a Better Tomorrow. The two committees donated a combined total of more than \$15.728 million to political campaigns and committees since 2017. The top recipients of these trial bar political donations are outlined below.

TOP LAW FIRM DONORS TO COMMITTEE FOR A BETTER TOMORROW

Since 2017, the Committee for a Better Tomorrow, the political action committee of the Philadelphia Trial Lawyers Association, raised more than \$12.3 million. Since 2017, 20 different law firms donated \$100,000 or more to the Committee for a Better Tomorrow, four of which donated more than \$1 million: Kline & Specter; Saltz Mongeluzzi & Bendesky; Ross Feller Casey; and, Feldman Shepherd. Four firms donated more than \$500,000 while five firms donated between \$250,000 and \$500,000.

TOP RECIPIENTS AND ANALYSIS

Since 2017, the Committee for a Better Tomorrow has donated more than \$100,000 to 27 individual candidates and committees. The Committee contributed \$1.3 million to Daniel McCaffery's (D) race for Pennsylvania Supreme Court in 2023. More than \$1 million went to Pennsylvanians for Judicial Fairness, a group funded by "traditional Democratic allies in organized labor and the Philadelphia trial bar" that supported Democratic candidates running for the Pennsylvania Supreme Court in 2023.[1] In 2021, the Committee for a Better Tomorrow spent \$850,000 on Maria McLaughlin's (D) unsuccessful race for Pennsylvania Supreme Court. Other judicial candidates who received over \$100,000 include Timika Lane, Sallie Mundy, Amanda Green-Hawkins, Deborah Kunselman, Debra Todd and Jill Beck.

LawPAC TOP LAW FIRM DONORS TO LAWPAC

Since 2017, LawPAC of Pennsylvania received more than \$3 million in contributions. Of these contributors, 12 law firms gave \$40,000 or more to Pennsylvania's LawPAC since 2017. The largest donor was Edgar Snyder & Associates, which gave almost \$150,000 combined to LawPAC, which is nearly \$60,000 more than Anapol Weiss, the next largest donor. Three additional firms – Goodrich & Geist, Fanelli Evans & Patel, and Kline & Specter – each gave more than \$75,000 to LawPAC since 2017. Four additional firms gave between \$55,000 and \$65,000, with the remaining three firms giving between \$40,000 and \$50,000.

TOP LAWPAC RECIPIENTS AND ANALYSIS

Since 2017, LawPAC has given 11 candidates for elected office and political committees more than \$50,000 in combined campaign contributions. Four of those candidates and committees received more than \$100,000, while the rest received campaign contributions between \$50,000 and \$100,000. Of the Top 11 recipients of LawPAC donations, all but two were Democrats, with most of the Democrats either serving on a top committee (like Sen. Vincent Hughes, the Ranking Member of the Pennsylvania Senate's Appropriations Committee) or serving in leadership (Sen. Jay Costa is the current Senate Minority Leader, and Rep. Joanna McClinton is the Pennsylvania House Speaker).

Two notable exceptions to this rule are the committees for former Sen. Pam Iovino and former Rep. Gerald Mullery. Sen. Iovino successfully won a competitive state senate special election in 2019 that flipped a previously Republican seat, while Rep. Mullery is a trial lawyer. Two Republicans – Sen. Frank Farry and former Sen. Jake Corman – were the only Republicans receiving more than \$50,000 from LawPAC since 2017.

Top Legal Services Advertisers and Contributions to Top Trial Lawyer PACs

Six of 2023's top legal services advertisers in Pennsylvania gave a combined \$2.6 million to LawPAC and the Committee for a Better Tomorrow since 2017. Most of that money came from two firms – Kline & Specter and Pond Lehocky – which donated approximately \$1.5 million and \$750,000 respectively. Two additional firms – Lundy Law and Edgar Snyder & Associates – donated between \$100,000 and \$200,000.

METHODOLOGY

Pennsylvania's campaign finance system lacks robust search functionality and does not offer the option to download data in bulk for comprehensive analysis. Due to this issue, data was downloaded showing all contributions between 2017 and 2023, meaning some data may have been lost in the process due to storage constraints. Furthermore, the downloaded data contained only file numbers associated with committees, omitting committee names, which posed additional challenges for analysis. Given these limitations, the datasets utilized are conservative in nature.
